**\*TRAILERS:** All trailers (small contractor trailers) must pay a daily fee or have a yearly decal . A trailer must have a yearly decal to be allowed to stay on the Island over-night.

**REMINDER: \$100 FINE FOR NOT TARPING YOUR TRUCK LOAD!**

**Please Note:** Full fee will be required for a replacement decal unless the old decal is turned in or proof of destruction of the old decal is given. With proof of destruction or turning in an old decal, the replacement fee is \$5.00.

**For each vehicle registered, the FIPOA must have a current copy of the Vehicle Registration, Proof of Current Insurance, and a Valid United States Driver's License for the Registered Owner/Driver of Vehicle.**

**The following is a partial list of Rules & Regulations concerning Contractors. It is not intended to be a complete list of regulations:**

- Contractors hours are limited to 7:30 AM to 7:00 PM.
- Weekend work is limited by a “no noise” policy with prior permission granted by Security or the General Manager prior to coming to the Island.
- Daily passes must be displayed in clear view.
- Absolutely no dumping on Fripp Island – heavy fines apply.
- All vehicles carrying yard debris must be covered by a tarp.
- Contractors are not allowed to fish or surf on the Island.
- No feeding wildlife on the Island.
- Obey the posted speed and weight limits on all bridges.
- Contractors may not enter the Island to solicit work.
- Contractors are not allowed to possess firearms on the Island.
- Pets must be kept on a leash at all times.
- No vehicle with a contractor’s decal shall be allowed to engage in any activity on Fripp Island other than for business, commercial or construction. A violation of this prohibition will cause the revocation of such privileges for that person or business entity.
- Contractors are not allowed on Island New Year’s Day, Christmas, Thanksgiving, Memorial Day, Labor Day, or 4th of July.
- All state laws are applicable and enforced.
